- ◆ "Per person" aircraft liability sublimits, including policies that limit your spouse, parent, or child to \$5,000 in bodily injury coverage. These policies also limit coverage for people outside the aircraft you are flying.
- ◆ Coverage that does not extend coverage for loss of use or nofault deductible protection.
- ◆ Legal defense costs are in addition to the liability coverage limit purchased.
